

## **DATASET USER LICENSE TERMS**

These Dataset License Terms (the “License Terms”) are constructed by Volvo Autonomous Solutions AB (“VOLVO”) for the use of the Volvo Highway dataset (the “Dataset”) made available through AI Sweden’s (“AI Sweden”) Data Factory (the “Data Factory”) to AI Sweden’s partners and project parties. By accessing the Dataset in any manner, you agree that (i) you have the authority to enter into the License Terms on behalf of yourself or your entity (as applicable) and (ii) that you or your entity shall be bound by the License Terms. These License Terms may be changed by VOLVO from time to time and upon VOLVO’s request AI Sweden shall update the License Terms available to the Dataset Users.

### **1. GRANT OF LICENSE**

VOLVO grants to the Dataset User (the “User”) an internal, limited, non-transferable, royalty-free, non-exclusive right to download or use the Dataset for academic research and for the purpose of training, testing and improving the Users’ AI-based applications and/or projects (for the avoidance of doubt, including AI based applications used by the User for commercial purposes) (the “License”). The User shall not use the Dataset for any purposes prohibited by applicable law.

### **2. RESERVATION OF RIGHTS**

**Ownership.** All intellectual property rights, title and ownership (including trademarks, patents, copyrights, etc.) in and to the Dataset remain with VOLVO (or its third party licensors, as applicable).

**Trademarks.** Nothing in the License Terms gives the User a right to use any of VOLVO’s trade names, trademarks, service marks, logos, domain names, or other distinctive brand features.

### **3. TERMINATION**

The User may terminate the License at any time by deleting any and all copies of the Dataset or

stop accessing the Dataset. The License will also terminate if you fail to comply with any term or condition of these License Terms whereupon the right to use the Dataset immediately ceases to apply. VOLVO may also terminate the License at any time at its sole discretion whereupon VOLVO will no longer make the Dataset available for AI Sweden.

### **4. DISCLAIMER OF WARRANTY**

The User expressly understand and agree that their use of the Dataset is at their sole risk and that the Dataset is provided “AS IS” and “AS AVAILABLE”. VOLVO shall have no obligation to provide any support related to the Dataset. VOLVO disclaims any and all warranties of any kind, whether express or implied including, but not limited to the implied warranties and conditions of merchantability, fitness for a particular purpose and non-infringement.

### **5. LIMITATION OF LIABILITY**

The User assumes the entire risk of using the Dataset. In no event shall VOLVO be liable for any damages, whether direct, special, incidental, indirect, or consequential, which may result from the use of the Dataset or any applications developed using the Dataset.

### **6. INDEMNIFICATION**

To the maximum extent permitted by law, the User agree to defend, indemnify and hold harmless VOLVO, its affiliates and their respective directors, officers, employees and agents from and against any and all claims, actions, suits or proceedings, as well as any and all losses, liabilities, damages, costs and expenses (including attorneys’ fees) relating to (i) the Users’ use of the Dataset, (ii) any application the User develops that have made use of the Dataset, including a claim that such application infringes or threatens to infringe any intellectual property right of any person, and (iii) any non-compliance by the User with these License Terms.

## 7. GENERAL

**Applicable law.** These License Terms, and any non-contractual obligations arising out of or in connection herewith, shall be governed by and construed in accordance with the substantive laws of Sweden, with the exclusion of its conflict of law rules.

**Disputes.** Any dispute, controversy or claim arising out of or in connection with this contract, contractual or non-contractual, or the breach, termination or invalidity thereof, shall be finally settled by arbitration administered by the Arbitration Institute of the Stockholm Chamber of Commerce (the “**SCC**”). The Rules for Expedited Arbitrations of the Arbitration Institute of the SCC shall apply. The place of arbitration shall be Gothenburg, Sweden
